Regular Meeting  
September 11, 2018

President Schaible called the meeting to order at 7:30 p.m. Roll was answered by B. Nolan, D. Brotherton, L. Zigler, D. Teberg, E. Murphy. B. Gable arrived at 7:40. E. Murphy motioned to accept the minutes for August regular meeting. L. Zigler seconded. Motion carried 5-0. B. Nolan motioned to accept the minutes from August Special Meeting. D. Brotherton seconded. Motion carried 5-0. B. Nolan motioned to pay the bills. D. Brotherton seconded. Motion carried 5-0. D. Teberg motioned to accept the Treasurer's Report. B. Nolan seconded. Motion carried 5-0.

Audience present was S. Johnson, she gave an update on the Girl Scout Troop can collection and asked if the Girl Scouts could volunteer to plant flower bulbs. L. McCarthy from TECEDA which is now North Western Illinois Economic Development was present and gave a presentation on what they have been working on the past year and asking the village to invest again. NWIED asked the Village for \$3,000.00. B. Nolan motioned to invest again. E. Murphy seconded. Motion carried 6-0. J. Ohms, L. Speer, J. Banke were also present in the audience.

B. Gable motioned to hire R. Douvikas as Building Inspector for the Village of Hanover at the rate of \$30 per hour. L. Zigler seconded. Motion carried 6-0. B. Gable motioned to pay R. Douvikas \$1,500.00 per building that he tore down of his properties out of the fund of building condemnation. L. Zigler seconded. Motion carried 6-0.

Comments were made of the need to put an Ad out to hire more Police Officer help.

B. Nolan made motion to pay Village Clerk a wage of \$150.00 for month of July and if future missed meetings are necessary. D. Teberg seconded. Motion carried 6-0.
