## Old Business -

<u>Task Force</u> is trying to improve the town and comments on all the properties being given letters and citations to clean up their properties. The Zoning Board of Appeals will send a legal written response to Elizabeth Tire in regards to their comments on the Villages Property Maintenance Code.

<u>Sidewalk Project</u> is still not okayed by the State of Illinois, who dictates the lumens of the lights. Most likely to be holding off on the project until next year.

Township Hall will be put out for bid in January 2020 and will be sold to the highest bidder.

<u>Solar Power</u> will be on the agenda for the Zoning Administrations next meeting and will talk with the Villages Lawyer about the ordinance on the panels and installation and upkeep.

<u>Truck</u>- The Villages new utility truck and utility box will be delivered by the end of September and the plow should be delivered by the middle of October.

Welcome Signs One welcome sign has been put up on the North end of town.

<u>Annexation</u> - The Enterprize Zone goes up hwy 84 to 20 to East Dubuque. Still working on more legal details of annexation.

<u>Lagoon Update</u>- Looking at Specs from when it was put in and checking on flow for when the pipe drainage is turned on. Gravel and Sand to be hauled in. Hopefully

done soon, no output until work is done. Usually the Lagoon gets shut down for the winter months come November.

## **New Business**
