## Village of Hanover Regular Meeting May 10th, 2022

President Schaible called the meeting to order at 7:00 p.m. Roll was answered by L. Speer, D. Brotherton, L. Zigler, E. Murphy, M. Holland. K. Gable was absent. Also in attendance was Deputy R. Schutts, Attorney T. Kurt, Village Clerk N. Ritchie, Zoning Admin S. Murphy.

L. Zigler motioned to accept the minutes from the April 19th,2022 regular meeting. M. Holland seconded. Motion passed 5-0. D. Brotherton motioned to accept the minutes from the May 3rd, 2022 special meeting. L. Zigler seconded. Motion passed 5-0.

After review of the monthly bills D. Brotherton motioned to pay the monthly bills. L. Zigler seconded. Motion passed 5-0. L. Zigler motioned to accept the treasurer's report. D. Brotherton seconded. Motion carried 5-0.

Garbage contract was discussed again. Cost price index was adjusted for the new contract and also discussed. L. Zigler motioned to accept the new garbage contract with the same company Montgomery trucking. E. Murphy seconded. Motion passed 5-0. Garbage clean up day will be May 26th, 2022.

Grants: Handicap ramps, 12 new ones to be put in with the new sidewalk project. Still waiting to hear more from the state.

Budget: after discussion and review, E. Murphy motioned to approve the 2022 budget. L. Zigler seconded. Motion passed 5-0.

D. Griffin-Sewer: spoke to the board about sewer lines on his property. Asked the board to have the village pay for some of the repair costs. Board discussed the homeowners responsibility of sewer lines to the city main.

MVP Stewart lift station: lift station is in need of some repairs and the cost to repair the old is \$2,505. New cost \$5250 plus freight. E. Murphy motioned to repair the old pump. L. Zigler seconded. Motion passed 5-0.

Bussan Landscaping put new mulch and weeding for the year for Fulton Rd hillside, parks and memorial. E. Murphy asked to add removal of dead plants to the contract. L. Zigler motioned to sign the landscaping contract. M. Holland seconded. Motion carried 5-0.

Village Sign was discussed and designs were looked at again. Money from the chamber and park district is collected in the amount of \$5000. Sign costs range greatly. E. Murphy motioned to order a sign and spend up to \$15,000 with the \$5,000 in donations. M. Holland seconded. Motion carried 5-0.

Audience was allotted time to speak.

Board comments: D. Brotherton asked about street repairs. Bathrooms and drinking fountains at the park were discussed.

July 4th was discussed and there will be fireworks. More info to come.

L. Zigler motioned to adjourn. M. Holland seconded. Adjourned at 8:36 p.m.
