Holland seconded. Motion passed 5-0. An Ordinance 2024-0514 Amending Section 50.05 Of Water and Sewer Use Rates, Of The Code Of Hanover, Village Of Hanover, Illinois was motioned to pass by E. Murphy and seconded by M. Holland. Motion passed 5-0.

Seal Coating was discussed and black top was proposed. No motions were made.

Pole Banners/ Christmas Deco: M. Holland will meet with K. Temperly to finalize details.
