Regular Meeting

August 13th, 2024

President Schaible called the meeting to order at 7:00 p.m. Roll was answered by D. Brotherton, N. Flack, E. Murphy, L. Zigler.

E. Murphy motioned to pay the monthly bills to not include NWILED. L. Zigler seconded motion passed 4-0.

D. Brotherton motioned to accept the Treasurer's report. N. Flack seconded. Motion carried 4-0.

Village Board Trustee Appointment: L. Zigler motioned to reappoint M. Holland to fill her vacancy of village board trustee. N. Flack seconded. Motion passed 4-0. M. Holland was sworn in by Attorney T. Kurt.

Grant Update – B. Stocks: Sewer lining/lead service line replacement updates and reimbursements were discussed. The mayor is requesting a list of completed replacements from 5 Star to make sure every replacement has been made before the village moves forward with another project.

Jessie Shekelton/Internet update: J. Shekelton was unable to attend. Attorney T. Kurt shared an update from J. Shekelton about the comprehensive work plan to complete the Fiber-to-the-Premise build out throughout its NW Illinois service areas which includes Hanover.

105-107 Jefferson St.: Attorney T. Kurt updated the board on the Motion for Hardship Discharge. Attorney T. Kurt is waiting on the Trustees report and no hearing date has been scheduled at this time.

Tree Trimming: Discussion of trees needing trimmed on and around utility lines in the village was discussed. N. Flack motioned to hire M&M Tree service to trim the trees. M. Holland seconded. Motion passed 5-0.

Zoning Report: C. Henkins reported that there was no update on the vehicle parking situation in the manor and waiting to hear from the fire marshal. D. Fary has requested a zoning change to a commercial zoned property to a residential zoned property.

Chief Wand/ Co-op Update/part-time pay: Chief Wand reported to the board that the police coverage co-op with the Village of Elizabeth is at a standstill, but will continue to work on the coverage sharing. T. Wand suggested comparable pay for part-time police officers as to what other Villages pay. E. Murphy motioned to pay part-time officers \$28 per hour, effective immediately. N. Flack seconded. Motion passed 4-1. L. Zigler abstained.
